### A. CALL TO ORDER

Tammy Paz-Combs called the meeting to order at 10:06 a.m.

### B. WELCOME/INTRODUCTIONS

### C. APPROVAL OF MINUTES (ACTION)

### D. 2014 Arizona Youth Survey

**Megan Armstrong** from the Arizona Criminal Justice Commission presented information regarding the 2014 Arizona Youth Survey. She indicated that the survey was given to 48,244 8<sup>th</sup>, 10<sup>th</sup> and 12<sup>th</sup> grade students. The survey indicated a slight increase how youth get prescription drugs (parents, family or relatives). In addition a slight increase how youth get marijuana (someone with a medical marijuana card, family or relatives).

**E. Request for Grant Applications Awards**

**Steve Selover** provided an update on the Parents Commission Request for Grant Applications (RFGA) awards. He mentioned that 13 applications were received and 2 organizations scored the highest and were selected for proposed funding. These two organizations include Childhelp, Inc. and the Arizona Board of Regents Southwest Interdisciplinary Research Center at Arizona State University.

**F. Sponsorship Request**

**Sonya Pierce-Johnson** disseminated a spreadsheet with three applicants which included: The Administrative of the Courts, Future for Kids and Fresh Start Women's Foundation. The review committee recommended funding all three programs. Commissioner Hellman made a motion to approve the funding request. The motion was seconded by Commissioner Linda Stiles and approved by all. (15.01.03)

**Tammy Paz-Combs** presented information regarding the existing sponsorship application's sample budget. She suggested that the budget outline items that are conducive to vendor contracts. The line items should include: speaker fees, AV equipment/rental and print material. Commissioner Chan made a motion to approve the sponsorship application changes. The motion was seconded by Commissioner Tim Reese and approved by all. (15.01.04)
