A. CALL TO ORDER

Debbie Moak, Co-Chair, called the Arizona Substance Abuse Task Force (Task Force) meeting to order at 3:04 p.m. with a quorum of twenty-four (24) members and sixteen (16) staff, presenters and guests present.

B. WELCOME AND INTRODUCTIONS

Debbie welcomed the commissioners and asked them to introduce themselves.

C. APPROVAL OF MINUTES

Members reviewed the meeting minutes for the Substance Abuse Task Force meeting that occurred on May 25, 2016. The minutes were approved as is, without needed modification or corrections.

D. REPORT: PREVENTION AND EARLY INTERVENTION (PEI) WORK GROUP

Questions on the topic of PEI resulted in the following information:

- The Director of Corrections, Director Charles L. Ryan, determines which policies to execute.
- Policy changes have been made by changing laws. Changes in law override policies.
- Ticketing for minor offenses is the result of the department of corrections having interpreted a law, and then developing a policy.

- Keeping inmates institutionalized is expensive. The Task Force will make recommendations that can impact existing policy.

Paying prisons based on severity of the inmate's offense incentivizes prisons to not release an inmate early or find favorable behaviors. **Jeff Taylor** reported the per diem rate for a level III inmate is \$66.25 per day.

H: PRESENTATIONS: OUR STORIES

The Substance Abuse Task Force and members of the public heard the experiences of three (3) families who have been impacted by substance abuse. Presenters were **Michelle Hamby, Lori Hennessey** and **Kristin Crowley**.

I: PRESENTATION ON PAIN MANAGEMENT

Dr. Paul Lynch and **Dr. Tory McJunkin** provided a presentation on pain management. In addition to the PowerPoint presentation, the following information was shared through dialogue:

- The presenters provided the background on how *Arizona Pain Specialists* was created.
- The treatment model is a homeopathic, multi-professional treatment approach that reduces the number of medications a patient is prescribed (as appropriate).
- The doctors utilize a Global Pain Scale that has been determined to have both internal and external validity.
- Patients who abuse opiates cost the system eight times (8x) more than people who do not use opiates.
- The clinic's overdose rate is close to 0%.
- *Arizona Pain Specialists'* program is cost effective with 96% of medications prescribed being generic. Their program also works to minimize emergency room visits.

- The doctors do treat patients with dental pain; however, less so because dental schools have improved their training around prescribing for dental work.
- Many of the patients the doctors see are referred to them after physicians no longer know how to treat them because the patients demand more medications. Medications are commonly titrated down at a rate of 10% per week.
- It is easy for a physician to write a prescription. The medical community does not know how bad the pain medication epidemic is.
- Pregnant women should not be on narcotics. There is a risk of detoxification causing death, so the doctors reduce their medications slowly over a period of 90 days, with the goal being not to stress the patients system.
- The physicians are willing to assist Governor Ducey's Substance Abuse Task Force to develop educational materials and trainings on the topics of pain management and appropriate prescribing.
